AN ACT Increasing Salaries of Oxford County Officials and Judges of Municipal Courts in Oxford County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 89, § 254, amended. The 10th paragraph of section 254 of chapter 89 of the Revised Statutes, as repealed and replaced by section 7 of chapter 372 of the public laws of 1959, and amended by section 60 of chapter 378 of the public laws of 1959, which relates to Oxford County, is amended to read as follows:

'**Oxford County:** County commissioners, \$1,800; chairman, \$2,000; clerk of courts, ~~\$3,300~~ \$3,800; county attorney, ~~\$2,800~~ \$3,200; county treasurer, ~~\$2,300~~ \$2,700; sheriff, ~~\$3,500~~ \$4,300; chief deputy sheriff, \$4,200; register of deeds, eastern district, ~~\$3,300~~ \$4,000; western district, ~~\$2,200~~ \$2,400; judge of probate ~~\$3,800~~ \$4,000; register of probate, ~~\$3,300~~ \$3,900; Western Oxford municipal court judge, ~~\$1,300~~ \$1,400; Norway municipal court recorder, ~~\$800~~; judge, ~~\$2,700~~ \$3,000; associate judge, \$800; Rumford municipal court judge, ~~\$3,500~~ \$4,000; recorder associate judge, \$800.'

Sec. 2. Appropriation. There is appropriated from the General Fund to the Department of Attorney General the sum of \$200 for the fiscal year ending June 30, 1962 and the sum of \$400 for the fiscal year ending June 30, 1963 to provide for the increase in salary of the county attorney of Oxford County. The breakdown shall be as follows:
