STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
SIXTY-THREE

AN ACT to Correct Errors and Omissions in the Public Laws Relating to Sea and Shore Fisheries.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 37-A, § 16, sub-§ VII, ¶ A, amended. Paragraph A of subsection VII of section 61 of chapter 37-A of the Revised Statutes, as enacted by section 1 of chapter 331 of the public laws of 1959, is amended to read as follows:

‘A. The holder of a current commercial shellfish and marine worm license may ~~also~~ buy or sell any of the above described worms.’

Sec. 2. R. S., c. 37-A, § 71, sub-§ V, amended. Subsection V of section 71 of chapter 37-A of the Revised Statutes, as enacted by section 1 of chapter 331 of the public laws of 1959, is amended to read as follows:

‘V. **Exception for wholesale dealer.** The holder of a wholesale sea food dealer’s and processor’s license in this State may at his regular place of business cut up lobster tail sections immediately prior to and for the purpose of preserving, canning or freezing them as processed stews, pies, newburgs or chowders.’

Sec. 3. R. S., c. 37-A, § 73, sub-§ II, ¶ C, additional. Subsection II of section 73 of chapter 37-A of the Revised Statutes, as enacted by section 1 of chapter 331 of the public laws of 1959 and as amended by section 32 of chapter 378 of the public laws of 1959, is further amended by adding a new paragraph to read as follows:

‘C. When an appeal has been taken from any conviction of any violation under this section, the commissioner may suspend, until final court

disposition, the respondent's lobster and crab fishing license and his right to obtain such a license.'

Sec. 4. R. S., c. 37-A, § 74, sub-§ II, repealed. Subsection II of section 74 of chapter 37-A of the Revised Statutes, as enacted by chapter 54 of the public laws of 1961, is repealed.
