SENATE AMENDMENT "B" to H.P. 175, L.D. 233, Bill, "AN ACT to Authorize Bond Issue in the Amount of \$3,850,000 for Student Housing at Central Maine Vocational Technical Institute, Eastern Maine Vocational Technical Institute, Northern Maine Vocational Technical Institute, and the Maine Maritime Academy, Site Improvements at Washington County Vocational Technical Institute, Heating and Air Conditioning Shop and Laboratory at Southern Maine Vocational Technical Institute, Completion of School Building at Peter Dana Point Reservation and Tribal Halls for Penobscot and Passamaguoddy Reservations."

Further amend said Bill in section 1 by striking out in the 6th line (5th line in L.D.) the figure "\$3,850,000" and inserting in place thereof the figure '\$4,500,000'

Further amend said Bill in section 6 under the caption "EDUCATION, DEPARTMENT OF" by inserting after the 5th line (same in L.D.) the following:

'Northern Maine Vocational-Technical Institute

Dormitory

650,000'

Further amend said Bill in section 6 under the caption "EDUCATION, DEPARTMENT OF" by striking out all of the last line and inserting in place thereof the following:

'Total Department of Education

\$2,855,000'

Further amend said Bill in section 6 by striking out the last line before the last paragraph and inserting in place thereof the following:

'TOTAL

\$4,500,000'

Further amend said Bill in section 8 in the 2nd line of the 2nd paragraph (first line in L.D.) by striking out the figure "\$3,850,000" and inserting in place thereof the figure '\$4,500,000'

Further amend said Bill in section 8 in the 2nd paragraph by inserting after the words and punctuation "Eastern Maine Vocational Technical Institute," in the 3rd and 4th lines (2nd and 3rd in L.D.) the words and punctuation 'Northern Maine Vocational Technical Institute,'
