COMMITTEE AMENDMENT "A" to S. P. 787, L. D. 2267, Bill, "AN ACT Providing Minimum Retirement Benefits for Certain Teachers."

Amend said Bill in section 1 by striking out all of the 10th line (same in L. D.) as follows: "Marion Kittredge Webster, Old High Road, RFD, Cornish, Maine 04020"

Further amend said Bill in section 1 by striking out all of the 21st and 22nd lines (19th and 20th lines in L.D.) as follows: "Nellie Kennedy Pettingill, Franklin Towers, Apt. 1112, 211 Cumberland Avenue, Portland, Maine 04111"

Further amend said Bill in section 1 by inserting at the end the following:

'Martha Palmer Page, E. Corinth, Maine  
Perley Harmon, Perham, Maine  
Helen Hutchins Bean, Mexico, Maine  
Minnie Austin Moore, Port Charlotte, Florida  
Mary Huntly Farris, Cutler, Maine  
Leona M. Cyr Schaller, Manchester, Connecticut  
Grace Adams Hatch, West Poland, Maine  
Martha Strachen Blake, Oakland, Maine  
Sarah Carr Tilley, Bucksport, Maine'

Further amend said Bill in section 2 by striking out in the 3rd line (2nd line in L.D.) the figure "\$16,320" and inserting in place thereof the figure '\$23,520' and by striking out in the 3rd line (same in L. D.) the figure "\$16,800" and inserting in place thereof the figure '\$25,200'

Further amend said Bill by inserting after section 2 the following:

'Sec. 3. Intent. It is the intent of the Legislature that the retirement benefits for

certain teachers provided for herein be limited to \$110 per month and that the provisions of the Revised Statutes, Title 5, section 1128 not apply to these benefits after the limit of \$110 has been reached. This limitation shall apply to those teachers named in the private and special laws of 1971, chapter 144 and the private and special laws of 1973, chapter 140.'

### Statement of Fact

The purpose of this amendment is to add names of teachers to the list and delete others; and freezes the benefits to \$110 per month.
