COMMITTEE AMENDMENT "A" to H.P. 1848, L.D. 2341, Bill, "AN ACT to Increase Salaries of County Attorneys and Assistant County Attorneys."

Amend said Bill in section 1 by striking out the last 2 lines (same in L.D.) and inserting in place thereof the following:

'county attorney, ~~\$8,500~~ \$9,500; first assistant county attorney, ~~\$6,000~~ \$7,000; second assistant county attorney, ~~\$6,000~~ \$7,000;

Further amend said Bill in section 2 by striking out all of the last 2 lines (last line in L.D.) and inserting in place thereof the following:

'county attorney, ~~\$8,500~~ \$9,500; assistant county attorney, ~~\$5,500~~ \$6,500;

Further amend said Bill in section 3 by striking out all of the last 3 lines (same in L.D.) and inserting in place thereof the following:

'county attorney, ~~\$10,000~~ \$11,000; first assistant county attorney, ~~\$7,000~~ \$8,000; second assistant county attorney, ~~\$7,000~~ \$8,000; third assistant county attorney, ~~\$7,000~~ \$8,000;

Further amend said Bill in section 4 by striking out all of the last line (same in L.D.) and inserting in place thereof the following:

'county attorney, ~~\$7,000~~ \$8,000;

Further amend said Bill in section 5 by striking out all of the last 2 lines (last line in L.D.) and inserting in place thereof the following:

'county attorney, ~~\$8,500~~ \$9,500; assistant county attorney, ~~\$4,500~~ \$5,500;

Further amend said Bill in section 6 by striking out all of the last 2 lines (same in L.D.) and inserting in place thereof the following:

'county attorney, ~~\$9,000~~ \$10,000; first assistant county attorney, ~~\$6,000~~ \$7,000; second assistant county attorney, ~~\$6,000~~ \$7,000;' (*Filing No. H-666*)

Further amend said Bill in section 10 by striking out all of the last 2 lines (same in L.D.) and inserting in place thereof the following:

Further amend said Bill in section 11 by striking out all of the last line (same in L.D.) and inserting in place thereof the following:

Further amend said Bill in section 17 by striking out in the 2nd line (same in L.D. ) the figure "\$88,250" and inserting in place thereof the following '\$32,000'

Further amend said Bill in section 17 by striking out in the last line (same in L.D.) the figure "\$44,125" and inserting in place thereof the following: '\$16,000' in 2 places.

Statement of Fact

This amendment is to provide a \$1,000 increase to the county attorneys and their assistants. This will result in a \$500 increase from January 1 to June 30, 1974 and another \$500 from July 1 to December 31, 1974.
