**AN ACT to Authorize a District Attorney and Assistant District Attorneys  
for Washington County.**

---

Be it enacted by the People of the State of Maine, as follows:

**Sec. 1.** 30 MRSA § 553-A, sub-§ 7, as enacted by PL 1973, c. 567, § 19, is amended to read:

7. There shall be one district attorney for Hancock ~~County and Washington Counties~~, which shall be known as "Prosecutorial District Number 7." He shall be elected by the electors of Hancock ~~County and Washington Counties~~ in the manner set forth in section 451.

**Sec. 2.** 30 MRSA § 553-A, sub-§ 9 is enacted to read:

9. There shall be one district attorney for Washington County, which shall be known as "Prosecutorial District Number 9." He shall be elected by the electors of Washington County in the manner set forth in section 451.

**Sec. 3.** 30 MRSA § 554-A, sub-§ 6, as enacted by PL 1973, c. 567, § 19, is amended to read:

6. The district attorneys for Prosecutorial Districts 6 ~~and 7~~, 7 and 9 shall each be allowed up to the sum of \$27,000 per year to be used for compensation of assistant district attorneys.

**Sec. 4. Appropriation.** There is appropriated from the General Fund to the Department of the Attorney General the sum of \$25,250 for the fiscal year ending June 30, 1979 to carry out the purposes of this Act. The breakdown shall be as follows:

Sec. 5. **Effective date.** This Act shall take effect January 1, 1979.
