HOUSE AMENDMENT" A" to COMMITTEE AMENDMENT" A" to H.P. 147, L.D. 150, Bill, "AN ACT to Revise the Service Charge for Local Vehicle Registration Agents."

Amend the amendment by striking out everything after the title and inserting in its place the following:

'Amend the bill by striking out all of the title and inserting in its place the following: 'AN ACT to Revise the Service Charge for Local Vehicle Registration Agents, to Require the Secretary of State to Give Notification when the Renewal of Motor Vehicle Registrations are Due and to Require the Director of the Bureau of Aeronautics to Give Notification when Aircraft Registration Renewals are Due'

Further amend the bill by inserting after the enacting clause the following:

'Sec. 1. 6 MRSA §52, sub-§1, ¶G is enacted to read: G. The director shall notify any holder of a registration, which is due to expire, of the date of that expiration. This notification shall be sent not more than 15 days nor less than 10 days before the expiration date of the holder's registration. In addition to the fee for registration required under subsection 2, there shall be an additional 25¢ fee, to cover the cost of mailing and processing the notification, which shall be paid at the time of registration.'

Further amend the bill by inserting at the beginning of the first line after the enacting clause the following: 'Sec. 2.'

Further amend the bill by striking out all of the underlined sentence after the amending clause and inserting in its place the following:

'The agents may charge any applicant a fee not to exceed \$1 over and above the required registration fee for each renewal issued and a fee not to exceed \$2 in the case of each new registration issued, the service charges to be retained by the municipality.'

Further amend the bill by inserting at the end the following: 'Sec. 3. 29 MRSA §106-B is enacted to read:

§106-B. Notification of expiration

The Secretary of State shall notify any holder of a motor vehicle registration, which is due to expire, of the date of that expiration. This notification shall be sent not more than 15 days nor less than 10 days before the expiration date of the holder's registration. In addition to the fee for registration required under section 242, there shall be an additional 25¢ fee, to cover the cost of mailing and processing the notification, which shall be paid at the time of registration.''

Statement of Fact

This amendment would require that the Secretary of State notify persons when their motor vehicle registrations will expire. The notice will be given between 10 and 15 days prior to the expiration. The cost of this notification would be covered by a $25 \not$ notification fee. The amendment would also the Bureau of require that the Director of/Aeronautics notify persons holding aircraft registrations when the registrations are about to expire.
