## STATE OF MAINE HOUSE OF REPRESENTATIVES 110TH LEGISLATURE FIRST REGULAR SESSION

COMMITTEE AMENDMENT" # "to H.P. 148, L.D. 174, Bill, "AN ACT to Revise the Charter of the South Berwick Water District."

Amend the bill by inserting before the enacting clause the following:

'Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the South Berwick Water District needs an increase in the debt limit to allow it to start replacing the old water main this spring; and

Whereas, in the judgment of the Legislature, these facts the meaning of create an emergency within/the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,'

Further amend the bill in section 3 by striking out everything after the amending clause and inserting in its place the following:

'Beginning at the junction of the South Berwick and Berwick town line with the Salmon Falls River; thence in a southerly direction by the Salmon Falls River to the junction of the Great Works River; thence in a southeasterly direction by the Great

Works River to the Great Works Bridge, so-called, at Brattle

Street; thence running in a general northeasterly and northerly
direction by and along the Great Works River to the intersection
of the Great Works River and the Agamenticus Road, so-called;
thence turning and running by and along the Agamenticus Road in
a general westerly and southerly direction to the marker which is
3,775 feet easterly from the junction of Portland Street and
Agamenticus Road; thence northwesterly to the junction of Portland
Street, called Route #4 and the Berwick - South Berwick town line;
thence in a due northerly direction a distance of 3,500 fee;
thence in a due southerly direction a distance of 4,000 feet,
or less, to the Berwick - South Berwick town line; thence in a
westerly direction to the point of beginning.'

Further amend the bill in section 6 by striking out everything after the amending clause and inserting in its place the following:

The trustees as such, shall receive as compensation for their services an amount to be determined by them not to exceed \$100 \$300 each per year; but and the treasurer may be allowed such compensation as the trustees shall determine.'

Further amend the bill in section 7 by striking out in

the last 3 lines (last 2 in LD) the following: "7-provided

the-total-indebtedness-of-the-said-district-shall-not-exceed-the

sum-of-\$400,000 and inserting in its place the following:

'; provided the total indebtedness of the said district shall not exceed the sum of \$400,000 \$2,000,000'

Further amend the bill by inserting, before the statement of fact, the following:

'Emergency clause. In view of the emergency cited in the preamble, this Act takes effect when approved.'

## Statement of Fact

This amendment clarifies the boundary description and puts specific limits on the debt and the trustees compensation, as requested by the town.
