#### IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND EIGHTY-ONE

### AN ACT to Establish Uniform Salaries for all Sheriffs.

Be it enacted by the People of the State of Maine, as follows:

- 1-A. Sheriffs' salaries. The sheriff in each of the counties is entitled to a minimum base annual salary of \$20,000. The county commissioners may authorize a higher annual salary within their county. Payments may be made monthly or weekly.

#### STATEMENT OF FACT

This bill sets a minimum base annual salary of \$20,000 for county sheriffs. Higher salaries could be established by county commissioners.
