- 'C. For those roads maintained by the municipality in the summer beginning July 1, 1982, that were maintained by the State between July 1, 1980, and June 30, 1982, \top the sum of:
  - (1) \$2,000 a mile for the first 5 miles or portion thereof;
  - (2) \$2,500 a mile for the next 5 miles or portion thereof; and
  - (3) \$3,000 a mile for each additional mile or portion thereof.'

## Statement of Fact

This amendment provides an allocation for amortization of the Department of Transportation building. It also makes program adjustments in the areas of administration, summer maintenance, traffic services, bridge maintenance and state aid. The amount of state aid is adjusted to fund the program recommended by the Maine Municipal Association which provides \$2,000 for the first 5

miles which a municipality assumes responsibility, \$2,500 for the next 5 miles and \$3,000 for additional miles.
