At the annual summer meeting of the village corporation, one 1 2 overseer, who is a resident voter as defined in section 12, 3 shall be elected to a one-year term by the resident voters; 4 one overseer, who is a nonresident voter as defined in 5 section 12, shall be elected to a one-year term by the nonresident voters; and there shall be a President of the Board 6 of Overseers to be elected as set forth in subsections 1 and 7 8 2

At the summer <u>annual</u> meeting in every July of odd-numbered years, the resident voters shall nominate and elect by written ballot a resident voter as a candidate for President of the Board of Overseers.

 as enacted by P&SL 1979, c. 30, §2, is amended to read:

At the summer annual meeting in every July of even-numbered
years, the nonresident voters shall nominate and elect by
written ballot a nonresident voter as a candidate for President of the Board of Overseers.

21 Sec. 5. P&SL 1927, c. 43, §9-A, 2nd to 8th sentences, 22 as enacted by P&SL 1979, c. 30, §4, are repealed and the 23 following enacted in their place:

24 There shall be one regularly scheduled annual meeting, held in the month of July or August. The date of the meeting 25 26 shall be as determined by the Board of Overseers. The primary business of the annual meeting is to appropriate and 27 28 vote to raise, or to appropriate or vote to raise, by tax 29 levy the moneys necessary to carry on the business of the 30 corporation, to elect the officers for the ensuing year and 31 for any other legal purpose which the village corporation is 32 authorized to undertake. Any other business of the village 33 may be dealt with at the annual meeting.
