1 Whereas, the actual incorporation cannot be accom-2 plished until the provision of this Act takes effect; and

3 Whereas, in the judgment of the Legislature, these 4 facts create an emergency within the meaning of the Consti-5 tution of Maine and require the following legislation as 6 immediately necessary for the preservation of the public 7 peace, health and safety; now, therefore,

8 Be it enacted by the People of the State of Maine as follows:

9 Sec. 1. Town of West Forks, incorporated. West Forks 10 with its inhabitants, is incorporated into a Plantation, town by the name of West Forks. The inhabitants of this 11 12 town are vested with the powers, privileges and immunities 13 which the inhabitants of towns within the State do or mav 14 enjoy. The town created shall take the effects belonging to 15 West Forks Plantation and shall also assume all of its obli-16 gations.

Sec. 2. Legislative district. Until the next legislative apportionment of Representatives, the Town of West
Forks shall remain in the same legislative district in which
West Forks Plantation is now classed.

21 Sec. 3. First meeting; how called. Upon acceptance of 22 this Act by referendum as provided in section 4, the board 23 of assessors of the plantation shall issue a warrant, in accordance with the general laws, for the first town meeting, 24 25 to be held within one year after passage of this Act. Noti-26 fication of the town meeting shall be filed bv the 27 plantation clerk with the Secretary of State for determining 28 the effective date of sections 1 and 2.

29 Sec. 4. Referendum; certificate to Secretary of State. 30 The board of assessors of the plantation shall submit this 31 Act to the legal voters within the territory embraced within 32 the limits of the proposed Town of West Forks, by ballot at 33 a regular or special election to be held within one vear 34 passage of this Act. This election shall be called, after 35 advertised and conducted according to Title 30, sections 36 2061 and 2065. The plantation clerk shall prepare the re-37 quired ballots, on which he shall reduce the subject matter 38 of sections 1 and 2 of this Act to the following question.

39 "Shall West Forks Plantation be incorporated into the 40 Town of West Forks?" 1 The voters shall indicate by a cross or check mark 2 placed against the word "Yes" or "No" their opinion of the 3 same. This Act shall be approved by a majority of the legal 4 voters voting at the election, provided that the total 5 number of votes cast for and against the acceptance of sec-6 tions 1 and 2 of this Act at the election equaled or 7 exceeded 50% of the total number of votes cast in the 8 plantation for Governor at the last gubernatorial elections.

9 The result of the vote shall be declared by the board 10 of assessors of West Forks Plantation and due certificate 11 shall be filed by the plantation clerk with the Secretary of 12 State.

13 **Emergency clause.** In view of the emergency cited in 14 the preamble, section 3 of this Act shall take effect upon 15 its acceptance by a majority of the legal voters at the 16 election. Sections 1 and 2 of this Act shall take effect 17 for all purposes at the first town meeting.

18 STATEMENT OF FACT

19 The purpose of this bill is to provide for a local 20 referendum on the conversion of West Forks Plantation into 21 the Town of West Forks.
