19 20 21	AN ACT to Remove Wallagrass Plantation from the Maine Forestry District.
22 23 24	Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
25 26 27 28	Whereas, the annual district tax on Wallagrass Plantation for its inclusion in the Maine Forestry District represents an undue burden on the inhabitants of that plantation; and
29 30	Whereas, tax certificates for the Maine Forestry District must be filed on or before May 1st of each year; and
31 32 33	Whereas, unless this Act is enacted as an emergency, it will not be effective before the filing of the tax certificates; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,
6 Be it enacted by the People of the State of Maine as follows:
7 12 MRSA §1201, 2nd ¶, last sentence, as repealed and replaced by PL 1965, c. 226, §34, is amended to read:
9 Municipalities: Allagash Plantation, E Plantation, Garfield 10 Plantation, Glenwood Plantation, Hammond Plantation 11 Macwahoc Plantation, Nashville Plantation, Oxbow Plantation 12 Reed Plantation, Wallagrass Plantation, Westmanland Plantation, 13 Winterville Plantation.
14 Emergency clause. In view of the emergency cited in 15 the preamble, this Act shall take effect when approved.
16 STATEMENT OF FACT
17 The purpose of this bill is to remove Wallagras 18 Plantation from the Maine Forestry District.
