15 **RESOLVE, Authorizing the Director of**
16 **the Bureau of Public Lands to Convey**
17 **Certain Lands of the State in Gorham,**
18 **Cumberland County.**
19

20 Director of the Bureau of Public Lands authorized to
21 convey certain lands. Resolved: That the Director of the
22 Bureau of Public Lands is authorized and directed to convey
23 by quitclaim deed to James A. Bauer, of North Waterboro,
24 County of York, State of Maine, for \$1, the following de-
25 scribed premises in the Town of Gorham, Cumberland County,
26 to have and to hold only so long as the premises are used
27 for educational purposes:

28 A certain lot of land on the northeasterly side of the
29 main road leading from Gorham to West Gorham and bounded and
30 described as follows:

31 Commencing on the northeasterly line of said road,
32 at an iron pin driven in the ground nearly opposite the
33 former residence of the late Augustus J. Stackpole, and
34 at the southwesterly corner of land of the heirs of

1 Francis Files; thence easterly, by land of said heirs,
2 twelve (12) rods less five (5) links, to a stone;
3 thence southerly, by land formerly of the heirs of
4 Reuben Lowell, seven (7) rods and eight (8) links, to a
5 wooden post; thence westerly, by said land, nine (9)
6 rods and three (3) links, to the northeasterly line of
7 said road; thence northerly or northwesterly, by said
8 road, ten (10) rods and nineteen (19) links to the
9 place of beginning, and is the same lot of land con-
10 veyed to said State of Maine, by deed dated July 24,
11 1909, recorded in Cumberland County Registry of Deeds
12 in Book 849, Page 324.

13 STATEMENT OF FACT

14 The purpose of this resolve is to clarify the title to
15 a piece of property in West Gorham owned by James A. Bauer.
16 The use of the property is restricted to educational pur-
17 poses.
