STATE OF MAINE 2 3 HOUSE OF REPRESENTATIVES (Filing No. H-668) 4 110TH LEGISLATURE 5 SECOND REGULAR SESSION COMMITTEE AMENDMENT "A" to H.P. 2086, L.D. 2028, Bill, 6 "AN ACT Enabling the Department of Educational and Cultural 7 8 Services to Administer the Education Block Grant Program." Amend the Bill by inserting before the enacting clause 9 10 the following: 11 'Emergency preamble. Whereas, Acts of the Legislature 12 do not become effective until 90 days after adjournment 13 unless enacted as emergencies; and 14 Whereas, the 90-day period will not terminate until after the beginning of the next fiscal year; and 15 16 Whereas, certain obligations and expenses incident to the operation of the Department of Educational and Cultural 17 Services will become due and payable immediately; and 18 19 Whereas, in the judgment of the Legislature, these 20 facts create an emergency within the meaning of the Consti-21 tution of Maine and require the following legislation as immediately necessary for the preservation of the public 22 23 peace, health and safety; now, therefore,' 24 Further amend the Bill in section 1 in the 3rd and 4th lines (page I, lines 24 and 25 in L.D.) by striking out the 25 following: ", effective July 1, 1982, 26 27 Further amend the Bill in section 2 in the 4th line (page 2, line 2 in L.D.) by striking out the "translations" and inserting in its place the 28 word 29 word 'tabulations' 30 Further amend the Bill in section 2 in the 7th line 31 (page 2, line 5 in L.D.) by striking out the word "the" 32 and inserting in its place the word 'this' 33 34 Further amend the Bill in section 2 in the 8th line

2 (page 2, line 6 in L.D.) by inserting after the words "sub-3 ject to" the word 'the'

Further amend the Bill in section 2 under the caption EDUCATIONAL AND CULTURAL SERVICES, DEPARTMENT OF by striking out all of the first line (page 2, line 9 in L.D.) and inserting in its place the following:

8 'Administration 9 All Other \$1,749,518'

10 Further amend the Bill by inserting at the end before 11 the statement of fact the following:

12 'Emergency clause. In view of the emergency cited in 13 the preamble, this Act shall take effect when approved.'

## STATEMENT OF FACT

15 The purpose of this amendment is to add an emergency 16 preamble and emergency clause to the bill. The amendment 17 also makes technical changes in the bill.
