STATE OF MAINE HOUSE OF REPRESENTATIVES (Filing No. H-699) 110TH LEGISLATURE SECOND REGULAR SESSION
COMMITTEE AMENDMENT " A " to H.P. 2127, L.D. 2045, Bill, "AN ACT Amending the Electricians' Licensing Law."
Amend the bill by striking out everything after the enacting clause and inserting in its place the following:
'32 MRSA §1202, sub-§1, ¶A, as repealed and replaced by PL 1981, c. 383, §5, and as amended by PL 1981, c. 470, Pt. A, §152, is repealed and the following enacted in its place:
A. For a journeyman electrician's or limited license, at least 8,000 hours of service as an apprentice or helper electrician or at least 8,000 hours of experi- ence in electrical installations as defined in section 1101, and satisfactory completion of a program of study comprising 576 hours as approved by the Electricians' Examining Board and completion of a course of not less than 45 hours in the current National Electrical Code, the course to be approved by the board. A graduate of a regional vocational high school 2-year electrical program approved by the Electricians' Examining Board shall be eligible to write the journeyman's examina- tion, as long as he has worked for 8,000 hours in the field of electrician or the equivalent. Any person who has at least 2 years' service as an apprentice or helper electrician may take the examination for a journeyman's or limited license and shall receive a li- cense if he passes, provided that he was licensed as an apprentice or helper electrician under subsection 3 on January 1, 1981, that he applies for the examination in accordance with section 1203 before January 1, 1983, and that he takes the examination within 6 months of his becoming eligible to do so. Upon the effective date of this paragraph, the board shall notify, by cer- tified mail, return receipt requested, all persons who were licensed as apprentice or helper electricians on barter subsection 3 on
January 1, 1981, of the provisions of the preceding

sentence. For a master electrician's license, at least 4,000 hours of service as a journeyman electrician or 2 ī 4 at least 12,000 hours of service as an apprentice or 5 helper electrician or at least 12,000 hours of experi-6 ence in electrical installations, as defined in section 7 1101, and satisfactory completion of a program of study comprising 576 hours as approved by the Electricians' Examining Board and completion of a course of not less 8 9 than 45 hours in the current National Electrical Code, 10 the course to be approved by the Electricians' Exam-11 12 ining Board; and'

year, the 14 Last Legislature stiffened electrician's 15 licensing requirements, mainly by increasing the amount of 16 experience required to take exams. This amendment allows 17 persons who were licensed as apprentice and helper electricians on January 1, 1981, to take the journeyman's or limited exam under the same requirements as existed when they began working toward their license. This amendment re-18 19 20 quires, that these persons apply for their license before 21 22 January 1, 1983, and take the exam within 6 months of gual-23 ifying. This amendment also requires the board to notify by certified mail, persons eligible under this limited grand-father provision. Finally, this amendment closes a loophole 24 25 in current law which permits a person to take the master's 26 27 exam without even complying with the educational requirement 28 imposed on applicants for the journeyman's license.
