'AN ACT to Adjust the Level of Reimbursement of Expenses for
15 Members of the Legislature.'

Further amend the bill by striking out all of sections
17 1, 2 and 3.

Further amend the bill in section 4, last sentence
19 (page 2, line 40 in L.D.) by striking out the figures "~~\$200~~
20 \$300" and inserting in their place the figure '\$200'.

Further amend the bill by striking out all of sections
22 5, 6 and 7.

Further amend the bill in section 8, first sentence
24 (page 3, line 27 in L.D.) by striking out the figures "~~\$25~~
25 \$35" and inserting in their place the figure '\$25'.

Further amend the bill by striking out all of sections
27 9, 10, 11, 12, 13 and 14.

Further amend the bill in section 15 under the caption
29 "LEGISLATURE" by striking out all of lines 2, 3 and 4 (page
30 5, lines 17, 18 and 19 in L.D.) and inserting in their place
