
2 1. To separate out specific costs of salaries, wages
3 and fringe benefits from each "Personal Services" line item
4 for each account in the county budget. This process does
5 not change any of the totals for Personal Services in the
6 bill;

7 2. To raise the appropriation for "Commodities" under
8 the budget for the Registry of Probate by \$2,000. This
9 increase provides funds for microfilming probate records;
10 and

11 3. To specify that fringe benefit funds shall only be
12 used for that purpose and that any unused funds in fringe
13 benefit accounts shall be carried forward to the next fiscal
14 year.
