17 AN ACT Relating to Licensing Fees for
18 Hunting.

20 Be it enacted by the People of the State of Maine as
21 follows:

22 Sec. 1. 12 MRSA §7101, sub-§4, as enacted by PL
23 1979, c. 420, §1, is amended to read:

24 4. Expiration. A junior hunting license issued
25 to a person who has passed his 15th birthday is valid
26 through the calendar year for which the license is
27 issued.

28 A 2-year license shall expire at midnight on December
29 31st of the calendar year following the year in which
30 it was issued.

31 Sec. 2. 12 MRSA §7101, sub-§5, ¶¶B to D, as
32 amended by PL 1979, c. 704, §2, is further amended to
33 read:

1 B. ~~Resident~~ Two-year resident hunting license ..

3 (16 years of age or older)

4 C. ~~Resident~~ Two-year resident combination hunt-
5 ing and fishing license ~~\$16~~ \$32

7 ery hunting and fishing license ~~\$16~~ \$32

8 Sec. 3. 12 MRSA §7301, sub-§7, as repealed and
9 replaced by PL 1979, c. 543, §26, is amended to read:

10 7. Fee. The ~~annual~~ fee for a 2-year resident
11 guide license is ~~\$34~~ \$68. The annual fee for a non-
12 resident guide license is \$130. The annual fee for
13 an alien guide license is \$155.

14 Sec. 4. 12 MRSA §7301, sub-§7-A, as enacted by
15 PL 1979, c. 543, §26, is amended to read:

16 7-A. Renewal. A guide whose license is not sus-
17 pended or revoked may renew that license ~~annually~~
18 biennially upon the payment of the ~~annual~~ fee stated
19 in subsection 7. Completion and passage of the
20 guide's examination is not a requirement for renewal.

21 Sec. 5. Effective date. This Act shall take
22 effect on January 1, 1984.

23 STATEMENT OF FACT

24 The purpose of this bill is to provide the
25 department with greater ability to predict its future
26 revenues and thus plan its operations more smoothly.
