the authority of this resolve shall be served on the 1 2 Secretary of State by attested copy 30 days before a 3 term of the court by the sheriff or either of his deputies in any county of the State. The conduct of 4 5 that action shall be according to the practice of ac-6 tions and proceedings between parties in the Superior Court and the liabilities of the parties, and ele-ments of damages, if any, shall be the same as the 7 8 the 9 liabilities and elements of damages between individu-The Attorney General is authorized and desig-10 als. 11 nated to appear, answer and defend that action. Anv 12 judgment that may be recovered in that civil action 13 shall be payable from the State Treasury on final 14 process issued by the Superior Court or, if appealed, the Supreme Judicial Court, and costs may be taxed 15 for Melanie Ann Clark if she recovers in that action. 16 17 Any recovery in that action shall not be in excess of \$50,000, including interests and costs. The hearing 18 19 shall be before a presiding Justice of the Superior 20 Court sitting with a jury.
