25 26 27 28 29 30	The State Harness Racing Commission, as hereto- fore established and hereinafter in this chapter called the "commission," shall consist of 3 members who shall be appointed and may be for cause removed by the Governor. Commencing January 1, 1987, all members of the commission shall be appointed or reap-
31	pointed by the Governor, subject to review by the
32 33	joint standing committee of the Legislature having jurisdiction over agriculture and confirmation by the

Legislature. No more than 2 members shall be of the 1 2 same political party. One member shall, in some 3 capacity, be connected with agricultural societies which operate pari-mutuel racing. Upon the expira-4 5 tion of the term of office of any member, his succes-6 shall be appointed for a term of 3 years. Any vacancy shall be filled by appointment for the unex-7 pired term. The members shall serve until their suc-8 9 cessors are appointed and qualified. So far as practicable, they shall be persons interested in the 10 establishment and development of a Maine breed of 11 12 standard bred horses and no member of the commission shall have any pecuniary interest in any racing or 13 14 sale of pari-mutuel pools licensed under this 15 chapter.

## 16 STATEMENT OF FACT

The purpose of this bill is to require legislative confirmation of all appointments to the State Harness Racing Commission by the Governor after January 1, 1987.
