16 17 18 19	This amendment amends the definition of sexual or affectional orientation and replaces the phrase "sexual or affectional orientation" with the phrase "sexual orientation."
20 21 22 23 24 25	It also corrects an error in the current law in a section dealing with real estate listings by replacing the date July 1, 1972, with the phrase since "such discrimination has been prohibited by statute." The effect of the change is to ensure that, for purposes of the Maine Human Rights Act, actions concern-
