7 COMMITTEE AMENDMENT " A " to S.P. 499,  
8 L.D. 1511, Bill, "AN ACT to Require the Department  
9 of Human Services to Conduct Demonstrations of Adult  
10 Day Care and Other Services through Long-term Care  
11 Facilities."

12 Amend the bill in section 1 in that part desig-  
13 nated "§6203." in subsection 2, 2nd paragraph, 4th  
14 line (page 4, line 24 in L.D.) by striking out the  
15 underlined word "charges" and inserting in its place  
16 the underlined word "fees"

17 Further amend the bill in section 1 in that part  
18 designated "§6206." in the 2nd line (page 5, line 15  
19 in L.D.) by inserting before the underlined word "An"  
20 the following: '1. Eligibility requirements.'

21 Further amend the bill in section 1 in that part  
22 designated "§6206." in paragraph A, first and 2nd  
23 lines (page 5, lines 18 and 19 in L.D.) by striking  
24 out the underlined words "an area agency on aging"  
25 and inserting in their place the following underlined  
26 words 'the department or its designee'

27 Further amend the bill in section 1 in that part  
28 designated "§6206." in the last paragraph (page 5,  
29 line 36 in L.D.) by inserting before the underlined  
30 word "Eligibility" the following: '2. Redetermin-  
31 ation of eligibility.'

32 Further amend the bill in section 1 in that part  
33 designated "§6207." in subsection 2, paragraph A, 4th  
34 and 5th lines (page 6, lines 17 and 18 in L.D.) by  
35 striking out the underlined words "the regional area  
36 agency on aging" and inserting in their place the  
37 following underlined words 'the department or its  
38 designee'

COMMITTEE AMENDMENT " A " to S.P. 499, L.D. 1511

1 Further amend the bill in section 2 by striking  
2 out the 2nd line from the end (page 7, line 4 in  
3 L.D.) and inserting in its place the following:  
4 'Adult Day Care'

5 Further amend the bill in section 2 by striking  
6 out all of the last line (page 7, line 5 in L.D.)  
7 and inserting in its place the following:

8 'All Other \$93,750 \$125,000'

9 STATEMENT OF FACT

10 This amendment clarifies one term used in the  
11 agreements and changes the assessment and certifica-  
12 tion procedure from one done by an area agency on  
13 aging to the broader category of the Department of  
14 Human Services, or its designee.

15 The first year appropriation is decreased to  
16 reflect the fact that the program will be starting  
17 after the beginning of the fiscal year and, there-  
18 fore, a full 12-months' appropriation is not re-  
19 quired.
