22 23 24 25	<b>Emergency preamble.</b> Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
26 27 28	Whereas, Penobscot County has certain expenses and liabilities which must be met as they become due; and
29 30	Whereas, it is necessary that the taxes for the year 1983, provided under the Resolves of 1983, chap-

31 ter 15, be immediately assessed in order to provide 32 the required revenue for the county; and 1 Whereas, in the judgment of the Legislature, 2 these facts create an emergency within the meaning of 3 the Constitution of Maine and require the following 4 legislation as immediately necessary for the preser-5 vation of the public peace, health and safety; now, 6 therefore, be it

7 Penobscot County; taxes reduced. Resolved: That 8 the amount of money to be raised by taxes in 9 Penobscot County is reduced; and be it further
