HOUSE AMENDMENT "A" to H.P. 1374, L.D. 1806,
Bill, "AN ACT Providing Conformity with the United
States Internal Revenue Code."

Amend the bill by inserting after section 2 the
following:

'Sec. 3 36 MRSA §5200-A, sub-§2, ¶G is enacted
to read:

G. For taxable years ending in the following
years, the sum of the following portions of the
deductions allowed for taxable year 1983 to the
taxpayer under the United States Internal Revenue
Code, Section 168:

(1) 1984 and 1985: 2 1/2% of the deductions
for 3-year property;

(2) 1984 through 1986: 5% of the deductions
for 5-year property;

(3) 1984 through 1988: 5% of the deductions
for 10-year property; and

(4) 1984 through 1991: 5% of the deductions
for 15-year property.'

Further amend the bill in section 3 in that part
designated "§5206." in subsection 3 by striking out
all of paragraph C and inserting in its place the
following:

1 Internal Revenue Code, Section 168:

2 (1) 1984 and 1985: 2 1/2% of the deductions
3 for 3-year property;

4 (2) 1984 through 1986: 5% of the deductions
5 for 5-year property;

6 (3) 1984 through 1988: 5% of the deductions
7 for 10-year property; and

8 (4) 1984 through 1991: 5% of the deductions
9 for 15-year property.'

11 designated "§5206." in subsection 3 by relettering
