15 16 17	IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND EIGHTY-FOUR
18 19 20 21	AN ACT to Include the Towns of Gilead and Upton within Vocational Region 9, Northern Oxford County.
22 23 24	Emergency preamble . Whereas, Acts of the Legis- lature do not become effective until 90 days after adjournment unless enacted as emergencies; and
25 26 27 28	Whereas, Upton was not originally in a vocational region because of its membership in an interstate compact with New Hampshire for the delivery of educa- tional services to its students; and
29 30 31	Whereas, Gilead was inadvertently omitted from inclusion in a vocational region when the regions were formed in 1974; and
32 33 34	Whereas, the students of Gilead and Upton attend schools operated by administrative units within Voca- tional Region 9; and

1 Whereas, it is timely and appropriate for Gilead 2 and Upton to be made a part of Vocational Region 9; 3 and

4 Whereas, the budget for Vocational Region 9 has 5 to be adopted prior to July 1, 1984, for fiscal year 6 1985; and

7 Whereas, the voters of Gilead and Upton would not 8 be able to vote on the 1984 budget unless this bill 9 is passed as emergency legislation; and

10 Whereas, in the judgment of the Legislature, 11 these facts create an emergency within the meaning of 12 the Constitution of Maine and require the following 13 legislation as immediately necessary for the preser-14 vation of the public peace, health and safety; now, 15 therefore,

16 Be it enacted by the People of the State of Maine as 17 follows:

18 Sec. 1. 20-A MRSA §8451, sub-§2, ¶H, as enacted 19 by PL 1981, c. 693, §§5 and 8, is amended to read:

20 Region 9. NORTHERN OXFORD COUNTY. Units lo-Η. 21 cated in this area shall include: Gilead; Hanover; Peru; Rumford; Upton, so long as it 22 23 sends its secondary students to schools operated 24 by administrative units within the region; School Administrative District No. 21-Canton, Carthage 25 and Dixfield; School Administrative District No. 26 27 43-Byron, Mexico and Roxbury; School Administra-28 tive District No. 44-Andover, Bethel, Greenwood, 29 Newry and Woodstock.

30 Sec. 2. State subsidy; computation. For the 31 fiscal year 1985, Gilead and Upton shall receive 32 state subsidy for vocational education to be computed 33 as if they were part of Vocational Region 9 in the 34 school year 1982-83.

35 **Emergency clause.** In view of the emergency 36 cited in the preamble, this Act shall take effect 37 when approved.

1	STATEMENT OF FACT
2	The reasons for adding Gilead and Upton to North-
3	ern Oxford Vocational Region #9 are set forth in the
4	emergency preamble.
5	The immediate phase-in of Gilead and Upton in the
6	school funding formula is appropriate since their
7	omission from the region was not caused by action on
8	their part, and the other units had the benefit of
9	the Uniform Property Tax method of sharing education-
10	al costs when the region was formed.
11	This bill results in approximately \$2,600 in ad-
12	ditional state aid starting in fiscal year 1985.
