26 27 28	Whereas, Sagadahoc County has certain expenses and liabilities which must be met as they become due; and
29 30 31 32	Whereas, it is necessary that the taxes for the year 1984 hereinafter mentioned be immediately assessed in order to provide the required revenue for the county; and
