16 17 18 19 20 21 22 23 24 25 26 27 28 29 30	In addition to the cost of search and rescue, the Department of Inland Fisheries and Wildlife shall be reimbursed annually from the General Fund, for fiscal year 1983 and thereafter, for 20% of the cost of ser- vices provided to other state agencies. These shall be reasonable services which are necessary in assist- ing state agencies in carrying out their charge and shall include assisting in the enforcement of land- use and environmental laws and regulations, animal control, general law enforcement and other such areas as shall be determined. To receive reimbursement, documentation shall be submitted by the Department of Inland Fisheries and Wildlife to the joint standing committee having jurisdiction over appropriations and financial affairs.
