1 the Secretary of State no later than September 19th 2 November 15th of each year.

3 Sec. 3. 30 MRSA §252, 4th ¶, as enacted by PL 4 1977, c. 148, §3, is amended to read:

5 The county commissioners shall hold a public 6 hearing in the county on these estimates prior to December February 1st. Written notice and a summary 7 8 of the county estimates shall be sent to the munici-9 pal officers. Notice of the hearing shall be given at 10 least 10 days prior to the hearing in a newspaper of 11 general circulation within the county. Written notice 12 and a copy of the estimates shall be sent by regis-13 tered or certified mail with return receipt re-14 quested, or delivered by hand in person, with proof received of the delivery, to the clerk of each munic-15 16 ipality in the county and to each member of the Leg-17 islature from the county at least 10 days prior to the hearing. The municipal clerk shall notify the mu-18 19 nicipal officers of the receipt of the estimates.

20 Sec. 4. 30 MRSA §253, first ¶, as repealed and 21 replaced by PL 1979, c. 351, §1, is amended to read:

22 These estimates shall be recorded by their clerk 23 in a book. A copy thereof shall be signed by the chairman of the county commissioners and attested by 24 25 their clerk, who shall transmit it to the office of 26 the Secretary of State on or before the first day of 27 each January prior to February 15th, together with 28 the county reports for the 2 preceding years, to be by him laid before the Legislature. 29

STATEMENT OF FACT

This bill changes the dates for preparing annual
county estimates from November 7th to January 20th
and revises public hearing and transmittal dates to
February 1st and February 15th respectively.
