3 Sec. 2. 21 MRSA §1252, sub-§2, as amended by PL 4 1981, c. 436, §3, is further amended to read:

5 Content of application. The application must 2. 6 contain a place for the following: Name of applicant, 7 address, address to which ballot is to be sent, title 8 and year of election at which ballot is to be cast, 9 name of party in which he is or desires to be enrolled, date of application and signature of appli-10 11 cant. It must contain a place for the applicant to 12 designate the reason for requesting an absentee bal-13  $10t_7$  the name of a person to whom his ballot may be 14 delivered and a place for the registrar to certify 15 whether the applicant is registered and the party in 16 which he is or desires to be enrolled. It shall con-17 tain a conspicuously-printed summary warning of the 18 provisions of Title 17-A, section 703.

## STATEMENT OF FACT

20 The purpose of this bill is to eliminate the rea-21 sons for requesting an absentee ballot. This allows 22 anyone who requests to vote by absentee ballot, for whatever reason, to do so without having to state the 23 24 reason and include it on the application.
