10 11	Amend the bill by striking out everything after the title and inserting in its place the following:
12 13 14	'Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
15 16 17 18 19	Whereas, as a result of the expansion of the Emergency Planning Zone, there has been a dramatic increase in the need for planning and response in the event of an emergency at the Maine Yankee Nuclear Power Plant; and
20 21 22	Whereas, the expanded planning base has resulted in the inclusion of persons who have not been previously involved; and
23 24 25 26 27 28	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,
29 30	Be it enacted by the People of the State of Maine as follows:

1 2 3	37-B MRSA \$954, sub-\$1, as repealed and replaced by PL 1985, c. 737, Pt. A, \$107, is repealed and the following enacted in its place:
4 5 6 7 8	1. Created. There is created the Radiological Emergency Preparedness Committee, as established by Title 5, section 12004, subsection 10, which is composed of 10 voting members as listed in this subsection:
9 10	A. Three members shall be appointed by the Lincoln County Commissioners as follows:
11 12	<pre>(1) One representative of Lincoln County fire departments;</pre>
13 14	(2) One representative of Lincoln County ambulance service personnel; and
15 16	(3) One representative of Lincoln County law enforcement agencies;
17 18	B. Three members shall be appointed by the Sagadahoc County Commissioners as follows:
19 20	(1) One representative of Sagadahoc County fire departments;
21 22	(2) One representative of Sagadahoc County ambulance service personnel; and
23 24	(3) One representative of Sagadahoc County law enforcement agencies;
25 26	C. One member representing the Maine Yankee Nuclear Power Plant;
27 28	D. The Director of the Maine Emergency Management Agency, who shall act as chairman;
29	E. The Commissioner of Public Safety; and
30	F. The Director of Health Engineering.
