Amend the bill in Part B in section B-1 in that part designated "HUMAN SERVICES, DEPARTMENT OF" under the caption "Administration - Regional - Human Services" by striking out all of lines 8 to 10 (page 241, lines 5 to 7 in L.D.) and inserting in their place the following: 'of funds to continue the closing of the same offices as in Public Law 1991, chapter 9 and no others, to'

28 Further amend the bill in Part P by inserting after section P-13 the following:

'Sec. P-14. 22 MRSA §3174-F, sub-§1, ¶E, as enacted by PL 1989, 32 c. 502, Pt. A, §72, is repealed.'

34 Further amend the bill in Part P by renumbering the sections to read consecutively.

Further amend the bill by inserting at the end after the 38 emergency clause the following:
