SENATE AMENDMENT " A " to COMMITTEE AMENDMENT "A" to H.P. 1729, L.D. 2420, Bill, "An Act to Legalize Marijuana for Medicinal Purposes"

Amend the amendment in section 3 in that part designated "§5821-A." in subsection 1 in the 3rd line (page 1, line 35 in amendment) by striking out the following: "17-A, section 1107" and inserting in its place the following: '22, section 2383'

Further amend the amendment in section 3 in that part designated "§5821-A." in subsection 2 in the 4th line (page 2, line 1 in amendment) by striking out the following: "17-A, section 1107" and inserting in its place the following: '22, section 2383'

Further amend the amendment in section 3 in that part designated "§5821-A." in subsection 3 in the 3rd line (page 2, line 8 in amendment) by inserting before the following: "growing" the following: 'trafficking by'

Further amend the amendment in section 3 in that part designated "§5821-A." in subsection 3 in paragraph B in the last line (page 2, line 19 in amendment) by inserting after the following: "1;" the following: 'or'

Further amend the amendment in section 3 in that part designated "§5821-A." in subsection 4 in paragraph B in the last line (page 2, line 34 in amendment) by striking out the following: "1; or" and inserting in its place the following: '1.'

Further amend the amendment in section 3 in that part designated "§5821-A." by striking out all of subsection 5.



18 **STATEMENT OF FACT**

20 This amendment makes the following technical changes.

22  
24 1. It removes references to possession of marijuana under  
the Maine Revised Statutes, Title 17-A, section 1107 and replaces  
them with references to possession of marijuana under Title 22,  
26 section 2383. This clarifies that possession of marijuana is  
currently a civil infraction in the State.

30 2. It clarifies that growing or cultivating marijuana is a  
form of trafficking marijuana under Title 17-A, section 1103.
