18 Changing the confidentiality procedures of certain investigative records managed by the Department of the Attorney General utilizing a retroactive application will require an 20 additional General Fund appropriation of \$89,150 in fiscal year 22 1994-95. This appropriation will provide funds for a Paralegal position, a part-time Assistant Attorney General position and 24 general operating expenses.

26 Authorizing the Department of the Attorney General to establish a fee for access to and copying of records to partially 28 offset the above-mentioned General Fund costs will increase General Fund revenue by \$41,600 in fiscal year 1994-95.'
