10	listed in the Maine Revised Statutes, Title 5, sections 12004-I and 12004-J as well as other advisory boards and commissions with
12	similar functions.
14	Pursuant to that law, the boards and commissions have been grouped by the subject areas within the jurisdiction of each
16	joint standing committee and each special select committee. This bill repeals certain boards and commissions identified within the
18	jurisdiction of the Joint Standing Committee on Agriculture.
