4 Part A repeals the Maine Aeronautical Advisory Board. 6 Part B repeals the Maine State Ferry Advisory Board. Part C repeals the Maine Highway Safety Commission. 8 10 Part D repeals the Medical Advisory Board (Licensing of Drivers). 12 Part E repeals the Maine Transportation Capital Improvement 14 Planning Commission. 16 Part F repeals the Travel Information Advisory Council. 18 This bill is submitted in compliance with Public Law 1991, chapter 844, section 8, which requires the Secretary of State to 20 submit legislation repealing all advisory boards and commissions listed in the Maine Revised Statutes, Title 5, sections 12004-I 22 and 12004-J as well as other advisory boards and commissions with similar functions. 24 Pursuant to that law, the boards and commissions have been grouped by the subject areas within the jurisdiction of each 26 joint standing committee and each special select committee. This 28 bill repeals certain boards and commissions identified within the

jurisdiction of the Joint Standing Committee on Transportation.
