32	As used in this chapter, unless the context otherwise indicates, the following terms have the following meanings.
34	1. Block. "Block" means an area defined as a block in the United States Census for 1990. A block is the smallest census

- 7. United States Census for 1990. "United States Census for 1990" means the population counts published in both printed and electronic media in March 1991 by the United States Census Bureau as the data for the State of Maine collected pursuant to Public Law 94-171.

- 1. Implementation. The Secretary of State shall implement the election districts adopted in this chapter pursuant to this Title and the Constitution of Maine. The Secretary of State shall inform the municipal clerks of the voting district or districts in which each municipality lies and shall provide copies of this chapter and district maps and narrative geographic descriptions of relevant election districts to those officials. The Secretary of State may resolve ambiguities concerning the location of election district lines consistent with subsection 2 and this chapter.
- 32 2. Interpretation. Where a road, street, waterway, boundary of a tract, boundary of a block group or boundary of a block is used as a boundary of an election district, the boundary 34 line lies at the center of the street or road, at the thread of 36 the waterway or at the boundary of the tract, block group or block, unless otherwise noted. When a description refers to a 38 bridge or railroad line, the district boundary lies at the center of the bridge or railroad tracks. When a description refers to a 40 railroad spur, it refers to the principal spur in the area. When a description uses the word "ocean," the district boundary line 42 lies coincident with the legal boundary of the particular community along or within the Atlantic Ocean. When an election 44 district includes a particular unorganized territory, it includes that unorganized territory as described in the United States Census for 1990, whether the territory is organized or 46 unorganized on the effective date of this chapter. Unless 48 otherwise noted, a district that names a municipality includes all of the municipality.

### §1204. Reapportionment

The state legislative districts established in this chapter must be reapportioned pursuant to the Constitution of Maine, Article IV, Part Third, Section 1-A, and congressional districts must be reapportioned as follows.

1. Procedure. In 1993 and every 10 years thereafter, when the Secretary of State has received notification of the number of congressional seats to which the State is entitled and the Federal Decennial Census population count is final, the commission shall review the existing congressional districts. If the districts do not conform to Supreme Judicial Court guidelines, the commission shall reapportion the State into congressional districts.

In making such a reapportionment, the commission shall ensure that each congressional district is formed of compact and contiguous territory and crosses political subdivisions the least number of times necessary to establish districts as equally populated as possible. The commission shall submit its plan to the Clerk of the House of Representatives no later than 120 calendar days after the convening of the Legislature in which apportionment is required. The Legislature shall enact the submitted plan of the commission or a plan of its own in regular or special session by a vote of 2/3 of the members of each house within 30 calendar days after the plan is submitted to the Clerk of the House of Representatives. This action is subject to the Governor's approval, as provided in the Constitution of Maine, Article IV, Part Third, Section 2.

2. Court apportionment. In the event that the Legislature fails to make an apportionment within 150 calendar days of the convening of the session in which apportionment is required, the Supreme Judicial Court shall make the apportionment within 60 days following the period in which the Legislature is required to act but fails to do so. In making the apportionment, the Supreme Judicial Court shall take into consideration plans and briefs filed by the public with the court during the first 30 days of the period in which the court is required to apportion.

3. Judicial review. The Supreme Judicial Court has original jurisdiction to hear any challenge to an apportionment law enacted by the Legislature, as registered by any citizen or group of citizens. If a challenge is sustained, the Supreme Judicial Court shall make the apportionment.

The State is divided into 2 districts for the election of Representatives to Congress. The districts are comprised as follows.

- 1. First District. The First District is comprised of the counties of Cumberland, Knox, Lincoln, Sagadahoc and York and the municipalities of Augusta, Belgrade, Benton, Chelsea, Clinton, Farmingdale, Fayette, Gardiner, Hallowell, Litchfield, Manchester, Mount Vernon, Oakland, Pittston, Randolph, Readfield, Rome, Sidney, Vassalboro, Vienna, Waterville, West Gardiner, Windsor, Winslow and Winthrop in Kennebec County.
- 2. Second District. The Second District is comprised of the counties of Androscoggin, Aroostook, Franklin, Hancock,

  Oxford, Penobscot, Piscataguis, Somerset, Waldo and Washington and the municipalities of Albion, China, Monmouth, Unity Township and Wayne in Kennebec County.
  - Sec. 3. Legislative findings. The Legislature finds that the State's population growth during the period from completion of the 1980 federal census to completion of the 1990 federal

census and population shifts within the State during the same
time period have combined to render the present apportionment of
the State's Senate, House of Representatives and 2 congressional
districts unconstitutional. The Legislature further finds that
the apportionment of the State's Senate, House of Representatives
and 2 congressional districts contained in this Act satisfies the
constitutional requirement of a fair and reasonable apportionment
when viewed by the standards of population equality, contiguity
of districts, compactness of districts and minimization of
crossing of the boundaries of political subdivisions.

The Legislature further finds that it is necessary to split Census Block 102B of Census Tract 9515 of the municipality of Limestone in Aroostook County between House District 141 and House District 142.

This Census Block has singular characteristics in that it is
largely populated by persons stationed or employed at Loring Air
Force Base, which is scheduled to be closed before the
Legislature is next reapportioned. The closure will result in a
significant decrease in population, and the block is split in
order to spread the impact of that singular population variation
over the 2 legislative districts.'

This amendment strikes the bill and replaces it with revised districts that implement the recommendations of the minority membership of the Legislative Apportionment Commission. The revised districts for the Senate, House of Representatives and congressional districts are based on population counts from the 1990 federal census.
