SENATE AMENDMENT "B" to H.P. 972, L.D. 1303, Bill, "An Act to Provide Property Tax Adjustments Necessary for the Town of Portage Lake"

Amend the bill by striking out the title and substituting 18 the following:

20 'An Act to Provide Property Tax Adjustments Necessary for the Town of Portage Lake, also Known as Portage'

Further amend the bill by striking out everything after the 24 title and before the statement of fact and inserting in its place the following:

Be it enacted by the People of the State of Maine as follows:

Sec. 1. Correct 1993 valuation. Notwithstanding any other provision in the Maine Revised Statutes, Title 36, the 1993 30 valuation for the Town of Portage Lake, also known as Portage, 32 for the purposes of calculating county taxes, school appropriations and any other decision regarding allocation of funds or assessment of taxes must be based on a valuation that 34 values the property of Georgia Pacific in Portage Lake, also known as Portage, at \$2,119,869. 36

38 Sec. 2. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.
