## Be it enacted by the People of the State of Maine as follows: 2 Sec. 1. 34-A MRSA §3201, as amended by PL 1991, c. 656, is further amended by adding at the end a new paragraph to read: 4 Beginning in fiscal year 1994-95, funds available to 6 maintain the Maine Correctional Institution - Warren, a unit of the Maine State Prison, must be appropriated or allocated to the 8 Maine State Prison program. 10 Sec. 2. Transition provisions. Notwithstanding the provisions of the Maine Revised Statutes, Title 5, all accrued expenditures, 12 assets, liabilities, balances or appropriations, allocations, transfers, revenues or other available funds in the Warren 14 Correctional Facility account must be transferred to the Maine 16 State Prison account. Sec. 3. Appropriation.
