Merging the University of Maine at Fort Kent with the University of Maine at Presque Isle may result in future General Fund savings beginning in fiscal year 1995-96. The amount of the savings that may result from the merger can not be determined until the required plan is developed and would not be realized until that plan is adopted.

14 If savings are realized that are attributable to General Fund appropriations, they must be deappropriated from the University of Maine System and appropriated to the Department of Education, General Purpose Aid for Local Schools program.

This amendment directs the Board of Trustees of the University of Maine System to develop a plan for merging the University of Maine at Fort Kent with the University of Maine at Presque Isle. The savings realized from this consolidation must be appropriated to General Purpose Aid for Local Schools.
