SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 236, L.D. 316, Bill, "An Act to Forbid an Employer from Hiring Replacement Workers during a Strike"

Amend the amendment in section 2 in that part designated "§595-A." in the first paragraph in the 5th line (page 3, line 50 in amendment) by striking out the following: "when" and inserting in its place the following: 'if, within 45 days of the commencement of the strike.'

Further amend the amendment in section 2 in that part designated "§595-A." in the first paragraph in the 5th line (page 3, line 50 in amendment) by striking out the following: "if"

Further amend the amendment in section 2 in that part designated "§595-A." in the first paragraph in the last line (page 4, line 8 in amendment) by inserting after the following: "section." the following: 'This section does not apply if the strike extends beyond 45 days.'

STATEMENT OF FACT

This amendment limits the restriction on the retention of replacement workers, if the strike ends or the striking workers offer to return within 45 days of the start of the strike.
