The Other Special Revenue that will be used to support this position is collected by the Business Enterprise Program from a percentage 42 of proceeds from dining facilities operated in association with the program and from proceeds from vending locations operated by 44 the program. Whether sufficient Other Special Revenue will be available to support this position in fiscal year 1998-99 is 46 uncertain at this time.' 48
