

type of rule change will represent a state mandate pursuant to the Constitution of Maine and the department will be required to fund at least 90% of the additional costs to local units of government.

Depending on the levels of MTBE set by these rules, the Ground Water Oil Clean-up Fund within the Department of Environmental Protection may incur significant additional costs beginning in fiscal year 1997-98 for cleaning up sites currently contaminated with certain levels of MTBE. The amounts can not be determined at this time. Any additional costs will place an additional burden on the fund which has a projected shortfall of \$20,000,000 in resources through fiscal year 1998-99.

In addition, changes in the allowable level of MTBE in drinking water may result in insignificant increases of dedicated revenue to the Ground Water Oil Clean-up Fund from cost recovery from nontank owners.'
