20 **Sec. 3. Adjustments to allocations.** Allocations under this Act
22 may be increased or adjusted by the State Budget Officer with the
23 approval of the Governor, to specifically cover those adjustments
24 determined to be necessary under any salary plan approved by the
25 Legislature, and those reclassifications or range changes that
26 have been approved by the Department of Administrative and
27 Financial Services and submitted for legislative review prior to
28 the effective date of this Act.

30 **Emergency clause.** In view of the emergency cited in the
31 preamble, this Act takes effect July 1, 1997.
