This bill may increase prosecutions for Class E crimes. If a jail sentence is imposed, the additional costs to the counties are estimated to be \$83.78 per day per prisoner. These costs are not reimbursed by the State. The number of prosecutions that may result in a jail sentence and the resulting costs to the county jail system are expected to be insignificant.

The additional workload and administrative costs associated with the minimal number of new cases filed in the court system can be absorbed within the budgeted resources of the Judicial Department. The collection of additional fines may increase General Fund revenue by minor amounts.'

## SUMMARY

18 This amendment adds a provision to the bill that requires the Commissioner of Inland Fisheries and Wildlife to submit an annual report to the Joint Standing Committee on Inland Fisheries and Wildlife describing all current and planned programs, 22 activities and rules relating to the conservation of endangered or threatened species. This amendment also corrects a spelling 24 error and adds a fiscal note.
