HOUSE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 632, L.D. 857, "Resolve, to Determine the Appropriate Tuition Rate for Public High School Students Who Live in a Municipality without a High School"

Amend the amendment in section 2 in subsection 2 in the first line (page 2, line 19 in amendment) by striking out the following: "nominated" and inserting in its place the following: 'appointed'

Further amend the amendment in section 2 in subsection 3 in the first line (page 2, line 22 in amendment) by striking out the following: "by the Commissioner of Education" and inserting in its place the following: 'jointly by the President of the Senate and the Speaker of the House'

Further amend the amendment in section 3 in the 4th line (page 2, line 39 in amendment) by striking out the following: "Commissioner of Education" and inserting in its place the following: 'appointing authority'

Further amend the amendment in section 6 in the last line (page 3, line 39 in amendment) by inserting after the following: "expenses" the following: ', except that the legislative member of the task force is entitled to receive legislative per diem as defined in the Maine Revised Statutes, Title 3, section 2 and expenses for attendance at meetings of the task force upon application to the Executive Director of the Legislative Council'

Further amend the amendment in section 7 in the 4th line (page 3, line 44 in amendment) by striking out the following: "15" and inserting in its place the following: '1'
