SUMMARY

This amendment replaces the resolve. It requires the 16 Commissioner of Human Services to adopt rules to standardize nursing home contracts to clarify the rights and obligations of residents. It allows contracts to contain other provisions 18 specifically allowed by the standardized contract. The amendment 20 also adds a fiscal note to the resolve.
