This amendment clarifies that only those provisions in the committee amendment that prohibit the stocking of alewives in Tripp Pond, Pond Brook and the Little Androscoggin River upstream of the Welchville Dam are repealed 90 days after the adjournment of the Second Regular Session of the 118th Legislature. The amendment also clarifies that the existing prohibition on stocking alewives in Hogan Pond and Whitney Pond includes waters that drain into or out of those ponds.
