HOUSE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 771, L.D. 1048, "Resolve, to Establish a Task Force to Review the Regional Applied Technology Centers"

Amend the amendment in section 2 by striking out all of subsection 1 and inserting in its place the following:

'1. One legislative member appointed jointly by the President of the Senate and the Speaker of the House;'

Further amend the amendment in section 6 in the 3rd line (page 3, line 8 in amendment) by inserting after the following: "members" the following: ', except for the legislative member,'

Further amend the amendment in section 6 in the next to the last line (page 3, line 10 in amendment) by inserting after the following: "meetings" the following: '. The member of the task force who is a Legislator is entitled to receive the legislative per diem as defined in the Maine Revised Statutes, Title 3, section 2 and expenses for attendance at meetings of the task force upon application to the Executive Director of the Legislative Council'

Further amend the amendment in section 7 in the last line (page 3, line 20 in amendment) by striking out the following: "extension." and inserting in its place the following: 'extension; and be it further'

Further amend the amendment by inserting after section 7 the following:

'Sec. 8. Appropriation. Resolved: That the following funds are appropriated from the General Fund to carry out the purposes of this resolve.
