The registrar shall make a complete list of all the eligible voters of the proposed district as defined in this Act. The list prepared by the registrar governs the eligibility of any voter. Voters who are residing outside the territorial limits of the proposed district, as defined in this Act, are not eligible voters and the registrar of voters shall exclude those voters from the registrar's list.'

Further amend the bill by inserting at the end before the summary the following:

42 FISCAL NOTE

This bill requires the municipality of Tenants Harbor to hold a public election. The additional costs of this state mandate are relatively minor. Pursuant to the Mandate Preamble, the two-thirds vote of all members elected to each House exempts the State from the constitutional requirement to fund 90% of the additional local costs.'
